Bandera CAD – 2016 Partial Exemptions by Entity

Purpose: To meet requirements of Property Tax Code as follows:

Sec. 11.46 COMPILATION OF PARTIAL EXEMPTIONS.

Each year the Chief Appraiser shall compile and make available to the public a list showing for each Taxing Unit in the District the number of each kind of Partial Exemption allowed in that tax year and the total assessed value of each Taxing Unit that is exempted by each kind of Partial Exemption. Acts 1979, 66th Leg., P. 2246, CH. 841, Sec. 1, Eff. Jan. 1, 1982. Amended by Acts 1981, 67th Leg., 1st C.S., P. 133, CH 13, Sec. 45, Eff. Jan. 1, 1982.
